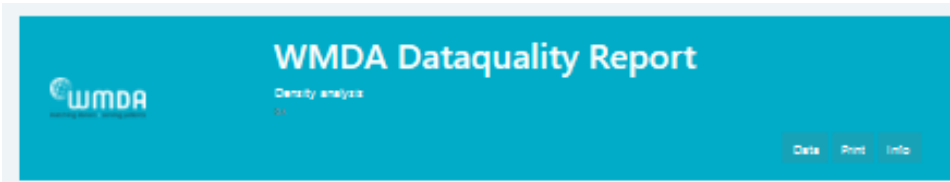
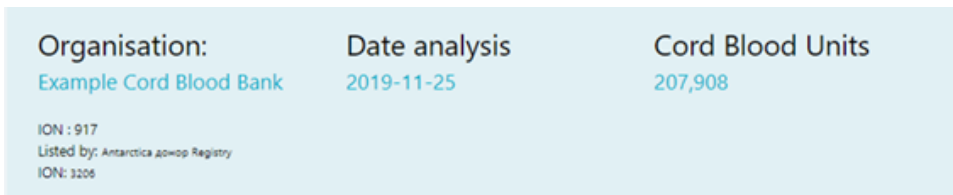
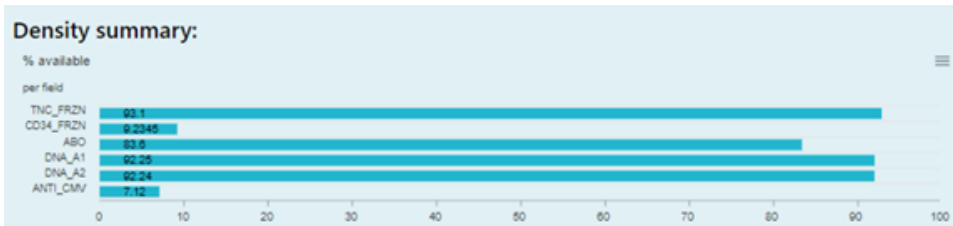
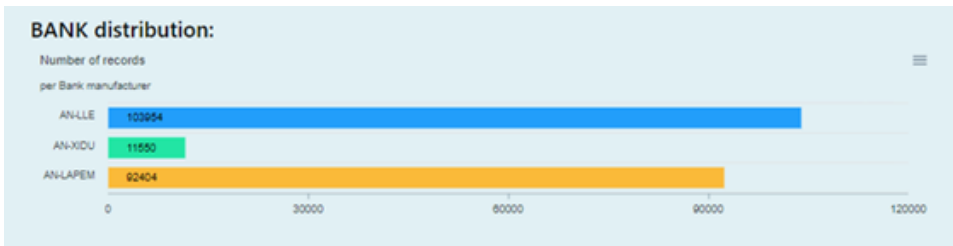
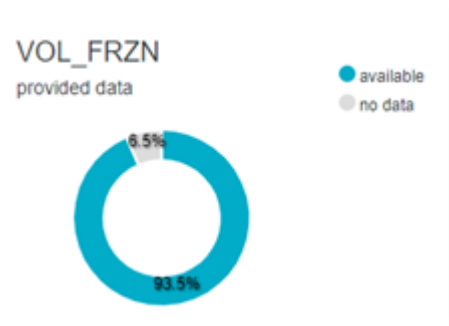

Section	Report example and Explanation
Header	 The report name and version. Extra features like: Print : Print report : you may print the report to PDF in major browsers for archival. Info : Link to background information about the DQ registry report Data : Access to the report data in JSON format, you can use this for your own data processing purposes.
Header	 Identifying organisation name and ION, listing organisation name and ION if applicable, date that the report is generated.
Data Summary	 The fields density for a listing organisation. Only field with value will be listed.
Data Distribution	 When the organisation is in charge of and uploading data for other CBBs and registries, then there will be the distribution bar chart. This bar chart provides the data distribution of the number of records of each organisation.
Charts for Focused fields	 This pie chart provides a visual indication of what percentage of provided records has data available for that field.

Charts for Focused fields	Trend last 12 months This line chart provides a trend analysis with the development of the % available data for that field for the given period. The trend is displayed RELATIVE. The global trend (the number of records provided over a period) can be found here.																																																							
Charts for Focused fields	Benchmark top 5 This combo chart provides a comparison of the density (%) available data from the top 5 global performers present in the WMDA international database.
